# <u>Please Read: AkaiCon 2023 Dealer Room Rules & Regulations</u>

#### 18+ Material

- It is the Artist/Vendor's responsibility to card all purchasers.
- Any materials which are sexually explicit, extremely graphically violent, or otherwise
  unsuitable for children must be displayed in a manner that keeps minors from seeing
  them.
- If any of these materials are found left out in the open, or the staff receives complaints, the Artist/Vendor will be asked to remove the material in question.
- If any Artist/Vendor sells inappropriate materials to minors, they may be removed from the Dealer Room with no refund of the booth space rental fee, arrest and/or criminal prosecution.
- We understand that some images may be considered "racy" while not being outright sexual. If you are unsure about an item, bring it to the attention of the Dealer Room Manager.
- Artists may post signs stating that they have adult materials for sale and/or commission.

# Copyright/Bootleg Material

- Artists/Vendors shall not distribute any copyrighted material at the Event unless all necessary rights have been obtained and all required royalties, fees or other payments have been paid.
- The Artist/Vendor bears all responsibility and risk for the items brought for sale. If a piece
  of art appears to be very similar to a licensed, copyrighted, etc. piece of art, the artist
  may be asked to remove it from display and sale.
- We have a no bootleg policy. It is considered the responsibility of the Artist/Vendor to know if their work infringes on this. Any Artist/Vendor found selling bootleg material will be asked to remove it from the Dealer Room. A repeated violation of this policy may result in Artist/Vendor's expulsion from the Event with no refund of the booth space ticket.
- Artists are advised to sell fan art at their own risk. The Event will not be held responsible
  and/or liable should an Artist be asked to remove fan art from their line up by a licensed
  company (Funimation, Cartoon Network, Bandai, Disney, etc.) and/or owner of original
  artwork in question.

### **Grab/Mystery Boxes & Bags**

- MUST have <u>relevant</u> contents and be <u>priced fairly</u> based on the label of the package advertised at booth
- If it is reported that the contents do not reflect what is advertised, you may be asked to remove them.
- Signage must convey accurate information and must not be misleading.

## **Swords And Weapons**

- The Event does allow the sale of swords and weapons. Our Weapon's Policy states that
  Attendees must immediately take purchases of weapons to vehicle/removed from Farm
  Bureau Expo Center.
- Firearms, concealed or otherwise, are prohibited on the entire premises, parking areas, buildings, operated by farm bureau expo center. The weapons prohibition shall not apply to a licensed/certified police officer. Violators will be prosecuted in as provided by law.

#### **Commissions**

Commissions taken for delivery at the Event, even if the commission was taken preconvention for delivery or at the convention for delivery, are between the Artist and
commissioner, and the Event is not a party in these dealings. Please make sure you get
contact information for one another as part of your dealings.
